Re: Golf Course Capital Equipment Purchase

Approved in the 2022-2023 golf course maintenance capital outlay budget is the purchase of one (1) Greens Roller. This item will be funded through the Village Vehicle Replacement Fund Program.

For comparative pricing, staff solicited quotes from area golf course equipment distributors and those quotes are as follows:

Reinders, Inc.	\$16,700.62
Revels Turf and Tractor, LLC.	\$16,570.00

The lowest quoted price for the Greens Roller came from Revels Turf and Tractor, LLC. in the amount of \$16,570.00 for one (1) – Tru-Turf RB48 Greens Roller. A total of \$22,000.00 was budgeted for this item. Bringing the purchase \$5430.00 below budget.

Considering all factors, I would recommend the Village of Bartlett purchase one (1) Tru-Turf RB48 Greens Roller and accept the quoted price from Revels Turf and Tractor, LLC. in the total amount of \$16,570.00 A total of \$22,000.00 was budgeted for the purchase of one (1) Greens Roller bringing the total cost \$5430.00 below budget.
